## EXTRACT OF THE MINUTES OF 06/2023-24 MEETING OF THE BOARD OF DIRECTORS OF PHARMAIDS PHARMACEUTICALS LIMITED HELD ON MONDAY, 12<sup>TH</sup> FEBRUARY 2024 AT THE REGISTERED OFFICE OF THE COMPANY SITUATED AT UNIT 201, 2ND FLOOR, BRIGADE RUBIX, WATCH FACTORY ROAD, PEENYA, BANGALORE- 560013, KARNATAKA, INDIA

TO REVIEW AND CONSIDER THE REQUESTS RECEIVED FROM THE PROMOTER'S SEEKING RECLASSIFICATION:

The Board was informed that Ms. Veena Lalwani, Mr. Abhishek Jain, Mr. Ghisulal Jain, Mr. Subhash Lalwani and Ms. Abhilekha Jain persons belonging to the 'promoter and promoter group' of the Company, through their respective letters, belonging to the 'promoter and promoter group' of the company, requested the Company for re-classification from the 'promoter and promoter group' category to 'public' category shareholder of the Company. Accordingly, intimation to BSE Limited in this regard was made on February 12, 2024, upon receipt of requests for reclassification from the aforesaid mentioned promoters.

The letters received from Ms. Veena Lalwani, Mr. Abhishek Jain, Mr. Ghisulal Jain, Mr. Subhash Lalwani and Ms. Abhilekha Jain were placed before the Board for its perusal.

The Board was informed that (a) Mr. Ghisulal Jain is a promoter of the company holds 36,070 (Thirty-Six thousand and Seventy) Equity shares of the Company, representing 0.16% of the paid-up equity share capital of the Company, (b) Mr. Subhash B Lalwani belonging to promoter group of the company holds 32,800 (Thirty-Two thousand Eight Hundred) Equity shares of the Company, representing 0.15% of the paid-up equity share capital of the Company, (c) Ms. Veena Lalwani belonging to promoter group of the company holds 15,645 (Fifteen thousand Six Hundred and Forty-Five) Equity shares of the Company, representing 0.07% of the paid up equity share capital of the Company, (d) Ms. Abhilekha Jain belonging to promoter group of the company holds 34,128 (Thirty-Four thousand One Hundred and Twenty-Eight) Equity shares of the Company, representing 0.15% of the paid-up equity share capital of the Company and (e) Mr. Abhishek Jain is a promoter of the company, does not hold any shares of the Company, representing 0.00% of the paid up equity share capital of the Company.

The Board was also apprised that each of them are satisfying all the conditions specified in Regulation 31A (3)(b) of the Listing Regulations.
